**ORDER:**

The Government vide reference 3<sup>rd</sup> and 4<sup>th</sup> read above have issued orders prescribing norms for re-apportionment of teaching staff under various managements viz. Government, Zilla Parishad / Mandal Praja Parishad Schools. As such, guidelines have been issued by the Commissioner of School Education, A.P., Amaravati to all District Educational Officers in the state to take up promotions from the feeder category of Secondary Grade Teacher and equivalent cadres to the vacant posts of School Assistant on adhoc basis vide reference 2<sup>nd</sup> read above.

2. Accordingly, certain Secondary Grade Teacher and equivalent cadres working in MPP/ZPP Management Schools have furnished their willingness for promotion to the cadre of **SCHOOL ASSISTANT(NON LANGUAGES)-BIOLOGICAL SCIENCE**.

3. After carefully examining their eligibility, the Secondary Grade Teacher and equivalent cadres as shown in the annexure are hereby promoted to the post of **SCHOOL ASSISTANT(NON LANGUAGES)-BIOLOGICAL SCIENCE** under Rule 10 (a) of A.P. State and Sub-ordinate Service Rules 1996, read with various orders/instructions issued for promotions of Secondary Grade Teacher and equivalent cadres into School Assistants in MPP/ZPP Management Schools, on purely adhoc basis. They shall exercise their options for place of posting in the promoted post during ensuing transfer counselling to be taken up by the Government through web counselling. The seniority in the promoted post shall be considered from the date of joining in the promoted post.

4. The above promotions are purely temporary and are liable for reversion at any time without any notice and without assigning any reason thereof for such reversion.

5. The promotion orders now issued are subject to the following conditions:

- a) That their promotion is subject to the outcome of the judgments pending before the Hon'ble High Court/ Supreme Court of India if any.
- b) That they shall abide by the terms and conditions stipulated by the Government and they are liable for any disciplinary action deemed fit for violation thereof if any.
